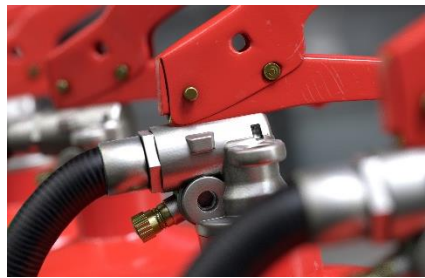

What tests do we complete during our visits?

Our fire extinguisher services are completed in compliance with BS5306, below is a brief overview of what is carried out during one of our service visits:

- ✓ Ensure each fire extinguisher has the correct pressure (not too high or low)
- ✓ Replace all small consumable parts, such as O rings and anti-tamper seals (included as standard in our service cost)
- ✓ Ensure all hoses and horns are clear of obstructions
- ✓ Ensure the body of the fire extinguisher is clean, free from rust, punctures and general damage
- ✓ Ensure each extinguisher is positioned and mounted correctly, with correct signage and free from obstructions
- ✓ Ensure each fire extinguisher's instructions are clear and distinguishable
- ✓ Report any non-compliances, such as units which have failed or are due a discharge test
- ✓ Complete and provide required paperwork for client's records
